Driver Guidelines and Policies

The Campus Recreation & Wellness (CRW) vehicles are available to use free of charge to approved groups of the University of North Georgia if they are not already being used by CRW or the University.

To be eligible to reserve a CRW vehicle, UNG employees or students MUST:

- Include a current REQUIRED Georgia DOAS Risk Management Motor Vehicle Training Course certification with this form upon submission.
- Not be a currently disqualified driver.
- At least 21 years of age.

A <u>minimum of 2 members</u> who are going on the trip must be eligible vehicle drivers (as listed above) at the time in which the reservation is made. A vehicle reservation request must be submitted at least 5 business days before the vehicle will be needed. A copy of the certificate of completion of the Motor Vehicle training for each driver must be submitted with the reservation request. Prices shown in this document are effective through May 31, 2024 and are subject to change without prior notice.

The using club or approved group is responsible for the following:

- a. Paying for all gas used. Failure to bring the vehicle back full of gas will result in a \$6/gallon charge to the renting group.
- b. Ensuring that the inside of the vehicle is clean when returned and not excessively dirty. This includes but is not limited to the following: dirt, mud, stained interior or ceiling/floor, garbage left in vehicle, etc. Failure to comply will result in a \$50 cleaning fee.
- c. Any damages beyond "Normal wear & tear".
- d. Lost keys.
- e. Keys must be returned to the CRW office by 10:00am.
