This letter is in response to your request to be exempt from licensure for the program for children your organization plans to operate at the above location. Based on a review of your program description, this program meets the criteria for exemption from state licensure as follows:

**591-1-1-.46(1)(b)1. (EXMT-12809) Programs which are owned and operated by any department or agency of state, county, or municipal government. This includes, but is not limited to, the customary school day, as defined in Georgia law, and before and/or after school programs in public schools operated by the public school system and staffed with school system employees and recreation programs operated by city or county parks and recreation departments and staff with city or county employees.**

### CONDITIONS OF EXEMPTION:

- Children Ages: 8 years – 17 years
- Operation Months: Year-round
- Operation Day: Monday – Sunday
- Operation Hours: 8:00 a.m. – 6:00 p.m.

**NOTE: Exemption approval means this program is not licensed as a child care learning center and is not required to be licensed because the program operations meet the criteria as described above. Therefore, the program is not required to comply with the Bright from the Start *Rules for Child Care Learning Centers*. Unless participating in the Childcare and Parent Services (CAPS) subsidy program, Bright from the Start will not regulate or routinely inspect this program and will only monitor the program to ensure compliance with exemption criteria and requirements or to collect data. The facility must meet all local requirements, such as complying with building, zoning, and fire regulations.**
