What we do

How does Univeristy of North Georgia protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does University of North Georgia collect my personal information?	We collect your personal information, for example, when you give us your Income information provide employment information provide account information give us your contact information pay us by check We also collect your personal information from other companies.
Why can't I limit all sharing?	 Federal law gives you the right to limit only sharing for affiliates' everyday businesspurposes—information about your creditworthiness affiliates from using your information to market to you sharing for non-affiliates to market to you State laws and individual companies may give you additional rights to limit sharing.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. University of North Georgia is affiliated with the University System of Georgia and the University of North Gerogia Foundation.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <i>University of North Georgia does not share with non-affiliates</i>
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial product or services to you.
