

UNG Honors Contract

At UNG, Honors coursework aims to increase students' understanding of and facility with the subject matter through innovative assignments. The Honors Contract option supports students in pursuing deepened engagement with course materials through a personalized experience developed in collaboration with the course professor. The Contract also supports faculty creativity and innovation; professors can use the contract to test new ideas on a small scale before piloting in a larger class.



The most successful Honors Contracts *empower students to take leadership and initiative in their own learning*. Strong Honors Contracts may include high-impact practices like service-learning, undergraduate research, global/diversity foci, off campus or out of classroom experiences. All Honors Contracts should include an end-of-term deliverable, such as a presentation, portfolio, essay, podcast, etc., which students may disseminate more widely beyond the course (e.g. to community stakeholders, a research conference, an Honors event).

Please also submit an original course syllabus (you may also submit a revised Honors Contract syllabus and/or other materials if you have those ready).
