This form is required of all F-1 international applicants. It is the applicant's responsibility to demonstrate that sufficient funding is available to meet all University and living expenses for his/her entire course of study/ program. The University of North Georgia is required by United States government regulations to verify that international students have adequate funding to cover all costs. Therefore, UNG issues an I-20 only after this form is completed and returned with the necessary support documents. You will need this same proof to apply for your F-1 visa at the U.S. Consulate and should therefore keep a copy of this form and all supporting documents.

The current estimate of expenses for an international F-1 student at the University of North Georgia for one academic year varies by program. Please identify the level for which you've been accepted, and submit the appropriate supporting documentation. All F-1 students accompanied by dependents (spouses and children under the age of 21) must have an additional \$4,000 per year of support for the first dependent and \$2,000 per year for each additional dependent. This is an estimate and subject to change without notice.

INSTRUCTIONS

- 1. Section A must be completed if your dependents will come to the U.S. in F-2 status.
- 2. Section B should include the amount to be provided by the sponsor(s) providing funds for your education.
- 3. Section C is required. ALL applicants must sign and date section C.
- 4. If you are being supported by your home government or university, a bank statement or letter is not required, but you must provide an official letter stating the terms of the sponsorship as documentation. The letter should be in English and be issued within 6 months of submission.
- 5. Section D is required if an individual is sponsoring you. Each sponsor must give the amount that will be provided for the duration of the F-1 program. For any individuals listed in Section B, (including yourself), the person being listed as the sponsor will need to provide a current, original certified bank letter or bank statement, indicating the ability to provide the guaranteed support. The bank letter/statement must meet the following requirements:
 - a. Include the sponsor's name and the amount maintained in the bank account
 - b. Must be in English
 - c. Be issued within 6 months of submission

For graduate students in all other programs, please provide supporting documentation based on the estimate of expenses indicated in your email communication from the Center for Global Engagement.
