Family Nurse Practitioner Post-Master's Certificate

Upon successful completion of the Family Nurse Practitioner Post-Master's Certificate program, University of North Georgia graduates will have **satisfied all educational** requirements to be eligible to sit for the **Family Nurse Practitioner (FNP)** certification exam required for practice as an FNP.

Family Nurse Practitioner Certification

The [American Nurses Credentials Center](#) (ANCC) and [American Academy of Nurse Practitioners](#) (AANP) provide nurse practitioner board certification examinations. Upon successful national certification, the student (who already holds a Georgia registered nurse license) can apply for state certification as an FNP.
