Upon successful completion of the Family Nurse Practitioner Post-Master's Certificate program, University of North Georgia graduates will have **satisfied all educational** requirements to be eligible to sit for the **Family Nurse Practitioner (FNP)** certification exam required for practice as an FNP.

Family Nurse Practitioner Certification

The American Nurses Credentials Center (ANCC) and American Academy of Nurse Practitioners (AANP) provide nurse practitioner board certification examinations. Upon successful national certification, the student (who already holds a Georgia registered nurse license) can apply for state certification as an FNP.
